Recognition to the Unions

†145. SHRI ABU ASIM AZMI: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

(a) whether it is a fact that Regional Labour Commissioner, Delhi and Mumbai have conducted elections for the group 'C' and 'D' employees' Union in MTNL, Delhi and Mumbai in the month of October, 2004;

(b) if so, the full details thereof;

(c) whether it is a fact that Government/department have not extended recognition and other facilities to the Union which secured first place in elections so far;

(d) if so, the reasons therefor; and

(e) By when Government/department are likely to extend recognition and other facilities to the Union which stood first in the elections?

THE MINISTER OF LABOUR AND EMPLOYMENT (SHRI K. CHANDRASEKHAR RAO): (a) Yes, Sir.

(b) MTNL Mazdoor Sangh has secured 12,474 votes out of 20,250 votes polled in MTNL, New Delhi and emerged as majority Union. MTNL Kamgar Sangh has secured 13,078 votes out of total 22,151 votes polled in MTNL, Mumbai and emerged as majority Union.

(c) The results of the election have been communicated to MTNL with the request to confer recognition on MTNL Mazdoor Sangh in MTNL Delhi and MTNL Kamgar Sangh in MTNL Mumbai, which have emerged as majority Union, for a period of two years.

(d) and (e) Question do not arise in view of reply to (c) above.
