PRICE RISE IN TEXTILES

994. SHRI KALYAN ROY: Will the Minister of FOREIGN TRADE/ विशेष वीपार नेवा be pleased to state:

- (a) whether Government's attention has been drawn to the news items "Reduced area of control gives a fillip to price rise in textiles" appearing in the Hindustan Standard dated the 22nd June,
- (b) if so, the reaction of Government thereto; and
- (c) the steps Government propose to take to curb this rise in prices in textiles?

THE DEPUTY MINISTER IN THE MINISTRY OF FORFIGN TRADE/ A. C. GEORGE): (a) Yes, Sir.

(b) and (c) There is no rise in the price of controlled varieties of cloth.

The prices of non-controlled cloth are dictated purely by the demand and supply position and by the popularity of certain brands as also by the availability and prices of raw cotton which goes into its production.

The Government has taken measures to arrest the rise in the prices of raw cotton.

At the instance of the Government Indian Cotton Mills' Federation have issued instructions to all the mills to stop forthwith all clubbed sales of cloth.
