 - (b) if so, the details thereof; and
- (c) whether any action has been taken by Government against the police officials responsible for beating the "Palledar"?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AF-FAIRS/ गृह त्वास्त्र में राज्य नदीं (SHRI K. C. PANT): (a) to (c) According to the Delhi Administration, Palledars of Khari Baoli and Naya Bazar areas went on strike on 26-7-1971 alleging that Shri Mohan, a Palledar, was beaten by officials of Police Station, Lahori Gate. Shri Mohan was suspected to have misappropriated eight bales of cotton yarn belonging to a merchant of Katra Ishwari Bhawan, Khari Baoli, Delhi, and was brought to the Police Station for interrogation.

The District Magistrate has ordered a magisterial inquiry into this incident of alleged beating by Police. A Sub-Inspector of Police has been placed under suspension.
