The Gandak Barrage has already been completed and work on the canal systems is in full swing in U.P. and Bihar and is expected to be substantially completed by the end of the Fourth Plan

The estimates prepared in 1961 assessed the cost of the project as Rs. 36.56 crores in Bihar and Rs. 15.47 crores in U.P. Revised Estimates approved in 1969 by the Planning Commission assess the cost as Rs. 108.18 crores for Bihar and Rs. 50.39 crores for U.P. Against this, the expenditure upto the end of 1970-71 has been Rs. 80.60 crores and Rs. 33.59 crores respectively. The outlay proposed in 1971-72 is Rs. 13 crores for Bihar, Rs. 4 crores Ior U.P. and Rs. 2 crores for Nepal Benefits.

(b) Irrigation is a State subject and funds for these are provided by the State Governments from within ihe State Plans for which Central assistance is given. The Central assistance to the two States has been as follows :-
