## SHORTAGE OF CEMENT

SHRI PRANAB KUMAR MUKHERJEE: Will the Minister of INDUSTRIAL DEVELOPMENT/श्रोद्योगिक विकास मंत्री be pleased to state:

- (a) whether it is a fact that there is an acute shortage of cement in the country; and
- (b) if so, the reasons thereof and steps taken to meet the shortage?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOP-MENT/ श्रौद्योगिक विकास मंत्रालय में उपमंत्री (PROF. SIDDHESHWAR PRASAD): (a) and (b) There has been local shortages of cement in certain regions in the country due to a spurt in the demand. Usually, the period between May-September is a busy season when the demand for cement increases. Maximum efforts are being made for the movement of cenient to the deficit regions. The full requirements of these regions could not be met due to shortage of wagons and non-availability of steamers. In addition, power and coal shortages have also affected the production and despatch schedules.

All cement producers have been alerted to expedite despatches to meet full requirements. Railway authorities have also been asked to provide additional wagons for movement of cement. Movement has also been allowed for longer distances by road as well as by steamer as a temporary measure to ge over the problem of shortage.
