Later information on the above lines is not available.

Information regarding total employment in manufacturing is available till the end of March, 1970 in the "Economic Survey 1970-71", (pp. 109-110) which indicates employment in manufacturing as approximately 46.8 lakhs in the public and private sectors taken together.
