(b) if so, what is the reaction of the Government to such an attitude of West Asian countries?

THE MINISTER OF EXTERNAL AFFAIRS/ विदेश मंत्री (SARDAR SWARAN SINGH) (a) and (b) Government of India are of the view that there has been inadequate understanding in many West Asian countries of the issues involved in the situation of Bangla Desh.
