- (b) if so, whether it is also a fact that some hurdles are being foreseen in this behalf in the 'mid-term appraisal' of Tenth Plan; and
  - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI M.V. RAJASEKHARAN): (a) Planning Commission has already dissolved wit effect from 1st October 2004 the Consultative Groups set up for the Mid-term Appraisal of Tenth Five Year Plan (2002—07).

(b) and (c) It has been decided to revert to the earlier practice of consulting individuals separately as part of the Mid-Term Appraisal process. The exercise of Mid-Term Appraisal of Tenth Plan (2002—07) is progressing satisfactorily and no hurdles are being experienced in the process of Appraisal of the Plan.

### Non-working of PCOs in far-flung areas

†\*30.'SHRI HARISH RAWAT: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) whether Government are aware of the fact that PCOs in far-flung rural areas of the country remain out of order due to prolonged faults in telephone lines and instruments;
- (b) if so, the number of the PCOs that remained out of order for more than three months, State-wise; and
- (c) the steps contemplated by Government for improving the telephone system at the PCO level?

THE MINISTER OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI DAYANIDHI MARAN): (a) Sir, PCOs generally do hot remain out of order for long duration. However, some Village Public Telephones (VPTs), working on MARR system, WLL system and on long overhead lines have remained out of order for longer duration than normal period for restoration.

(b) PCOs other than VPTs lying faulty for more than 3 months; NIL. State-wise list of VPTs that are lying faulty for more than three months as on 31.10.2004 is given in Statement-I (See below).
