- 78. SHRI C. RAMACHANDRAIAH: Will the Minister of MINES be pleased to state:
- (a) whether Government have allowed private investment in mines and minerals sector;

THE MINISTER OF MINES (SHRI SIS RAM OLA): (a) As per the National Mineral Policy (NMP), 1993, the non-fuel and non-atomic mineral sector has been thrown open for private investment including Foreign Direct Investment.

(b) and (c) For non-fuel and non-atomic minerals, the above mentioned National Mineral Policy is equally applicable to all States in the country.
