INDO-YUGOSLAV TRADE RELATIONS

(b) if so, the details thereof and whether any formal communication in this regard has been received from the Government of Yugoslavia; and

(c) the reaction of the Government of India in this regard and how the same would affect our trade with Yugoslavia ?

MISHRA) : (a) to (c) A statement is laid on the Table of the House.

STATEMENT

The Yugoslav suggestion for replacing the existing rupee payment arrangement between the two countries with a system of trading in multilateral currencies has been under examination between the two Governments for some time. Since the visit of the official delegation referred to in the press report appearing in the Patriot of 12th February, 1971, a delegation led by the Yugoslav Minister of Economy has visited India in July 1971. As a result of the discussions held with this delegation, it has been decided that the current

trade and payments agreement will be extended upto 31st December, 1972 after which date all payments between the two countries in respect of new transactions should be made in convertible currencies. This decision as subject to ratification by the Governments of the two countries.

Since the new system of settlement of transactions in convertible currencies will come into force only in 1973, it is too early to say how the trade will behave when payments in convertible currencies are introduced in 1973- It will be the endeavour of the two Governments to expand trade and economic co-operation between the two countries.

विवरण

चीन द्वारा व्यापार आंकड़े सविस्तर प्रकाशित नहीं किये जाते । अन्य स्रोतों के माध्यम से प्राप्त जानकारी से प्रकट होता है कि इस क्षेत्र के देशों को चीन से होने वाले निर्यातों में अधिकांशतः मूल उत्पाद, वस्त्र और हल्का इंजीनियरी माल शामिल है । भारत के निर्यातों में इंजीनियरी माल, रसायन सामग्री, खनिज अयस्कों और वस्त्रों पर बल दिया जाता है । प्रतियोगिता अन्तर्राष्ट्रीय बाजार की कुंजी है और इस क्षेत्र तथा अन्य क्षेत्रों में प्रतियोगी बने रहने के लिये भारत अविरत रूप से प्रयत्नशील है । क्वालिटी और कीमत की चुनौतियों का सामना करने के अतिरिक्त व्यापारिक लेन-देन के विस्तार तथा विविधीकरण के लिये उपयुक्त संवर्धनात्मक उपाय किये जाते हैं ।

एशियाई देशों को अथवा जो इकाफे क्षेत्र के नाम से विख्यात हैं, भारत के निर्यात वर्ष 1966-67 में 243 करोड़ रुपये से बढ़ कर वर्ष 1969-70 में 379 करोड़ रुपये के हो गये । वर्ष 1970-71 (अप्रैल-दिसम्बर) में ये निर्यात 310 करोड़ रु० तक पहुँच गये जब कि वर्ष 1969-70 की उमी अवधि में 266 करोड़ रुपये के निर्यात हुए थे ।
