zation programme has been impressed on State Governments, many of whom have taken suitable steps to organize the flow of institutional finance to the mechanized fishing industry. The question of providing subsidy on fuel used by fishing boats has also been taken up for consideration. The observations of the Programme Evaluation Organization are being kept in view in finalizing the Annual Plans of the States. The report has also been furnished to the State Governments who are concerned with the implementation of the programmes of mechanization, refrigeration, marketing, training and welfare.

demonstration outside the Times of India building in New Delhi. demonstrators resented the publication of an alleged incorrect report in the Nav Bharat Times about the Head of their Mission on the 11th November though the Newspaper had on the 13th itself published an explanation on behalf of the Mission. When the before the demonstrators assembled building, a Member of the Editorial staff of agreed to meet their paper representatives. However, the demonstrators suddenly became riotous and started pelting stones at the building and the Policemen who had sought to prevent the entry of the demonstrators into the building. To disperse the riotous mob Police had to use tear-gas. In the course of these incidents 9 Policemen and 5 employees of the Times of India Press were injured. One of the injured Policemen, a CRP constable, subsequently died in hospital. Som= damage was also caused to the building and some of the demonstrators sustained minor injuries. A case has been registered in connection with these incidents and is being investigated according to law. 17 demonstrators were arrested on the spot. A sum of Rs. 2500 has sanctioned to the family of the been deceased constable for immediate relief.

Minister as to when the police came to know that there was a crowd assembling in front of the 'Times of India', and may I know whether the 'Times of India' press is in a remote place remote from the capital of India, Delhi, and whether it has a big fieTd in front of it where even if there was a crowd assembling and gathering the police need not have taken cognizance of it? The point that arises out of this is that the 'Times of India' building is situated On the Bahadurshah Zafar Marg. a main road in the capital of India, and if even ten people or fifteen people start assembling, they block the road, and the immediate duty of the police then is either to disperse the crowd or to see that the traffic is not hindered. In this case, the hon. Minister said that all of a sudden the crowd turned riotous. They could not have turned riotous when five people had gathered there. They turned riotous according to the report in the newspaper when they were already more than 500 or 600; it may be even one thousand. Now, what did the police do till the crowd became one thousand? They should have prevented the crowd from obstructing the traffic itself, and subsequently when it assembled in front of that newspaper press, for which the hon. Minister is now showing a lot of sympathy. The police should

have taken cognizance of the crowd at the very beginning in order to preserve the freedom of the press. What did the police do at that particular moment? All thesa things came to happen later on because the police were negligent in the beginning.

SHRI K. C PANT: Sir, the General Secretary of the Mission had written to the District Magistrate a day earlier and had indicated that the Mission wanted to hold a peaceful demonstration outside the press. The police was already there. It was not as though they arrived after the assembly of the crowd; they were already there. Sufficient police arrangements were made and within IS minutes, that is, at 11.15, the SDM and the DSP also arrived there. Now, they proceeded to tackle the problem in a manner which is usually advocated by the House. Instead of attacking the people who had assembled there, they tried to prevent a breach of peace by talking to the Manager of the press, the Times of India, and the demonstrators who had assembled, trying to arrange a meeting between them so that the whole thing would blow over without a breach of peace. At one stage the Manager agreed to send an Assistant Editor and it seemed as though the two would meet and the whole thing would blow over, but later on the meeting did not take place because the demonstrators did not meet him and then, at that stage, the crowd started pelting stones and started approaching the building. So, the people in this case has acted with exemplary patience and has tired its best to avoid a situation which would lead to use of force and injury to persons. I think the police should be...

SHRI LOKANATH MISRA: On that point I have no complaint at all. My complaint is lack of alertness on the part of the police. I did not complain that they did not have the patience. They did not visualise that such a contingency might arise—that is what I was saying.

SHRI K. C. PANT: I do not think it is correct to say that they were not alert, Sir. But I think, one can say that the people outside should have shown patience. They did not. They were aroused, they were provoked by some of their own people instead of waiting for the dialogue to continue so that the two could meet and resolve the problem. After all, what was the problem? The problem was, a certain news item appeared in the newspaper. They said "we will publish the other version also". The matter should have ended there. It is naturally a small matter but it took an ugly turn. The police behaved with commendable patience, but it is unfortunate that this should have happened.

Lots of Government officers are seen going to these ashrams today, accompanying these gurus. I do not want to name the officers. But I know quite a few Joint Secretaries and Secretaries openly on their tables t>ut up the of these gurus and yogis, and through this a lot of shady deals are transacted. And there is no doubt that some of the foreign missions are also involved in it. I would only like to put this question to Mr. Pant: Would he inquire into the source of finance not only of this particular yogi but also the other vogis who are giving all these lectures and touring over India either in planes or in trains 01 in bullock-carts because it is a very serious And in future, unless he is strong, the security of the whole country and the

SHRI K. C. PANT: Investigation is going on already.

SHRI CHITTA BASU (West Ben gal): May I know from the hon. Minis ter whether there is any attempt on the part of the police to collect intel ligence about this Balayogeshwar, his antecedents, where he has come from, object what is the of his coming Delhi and the to purpose of his holding that kind of meeting and demonstration, etc? And why did the police itself give permission to hold a demonsstra' tion of that nature? I think something should be known about that Balayogeshwar himself. This is all the more important because of the fact that the Home Minister has agreed that somebody on behalf of that leading light met him and sought his permission to hold that kind of meeting ' in India Gate which was permitted the previous years, but this year it has been rejected. What is the basis of rejection? Is it merely because of i sanitary consideration or some i

consideration also? Would the hon'-ble Minister kindly assure the House

that Yogis of this nature would not be allowed to play with the religious sentiment of our people which is ultimately to create disaffection among a section of the people, setting one community against another, which affects the national integrity? Would the hon'ble Minister assure the House that in this particular case there will be a comprehensive enquiry into all these matters, particularly in order to know the antecedents of this particular Yogi, the object of having this kind of demonstration and whether there is any link of this Yogi with some person placed in authority, some Minister or some high official of the Government?

SHRI K. C. PANT: Taking the last question first, to the best of my knowledge, there is no connection,

SHRI CHITTA BASU: To the best of your knowledge.

SHRI K. C. PANT: The trouble with such question is that the Minister does not know what to reply because it is like asking a person: "When did you stop beating your mother-in-law?" If he says "Yes", then you draw a conclusion and if he says "No", then also you draw a conclusion. Therefore, at best I can say is "to the best of my knowledge".

THE LEADER OF OPPOSITION (SHRI M. S. GURUPADASWAMY): Not mother-in-law but wife.

SHRI K. C. PANT: Each according to his own practice. According to the information available with us the Divine Light Mission was founded by Param Gurudev Hansji Maharaj in 1961 in Hardwar. He died in 1966.-Before his death he nominated his youngest son to succeed him as the head of the Mission. This present Balyogeswar is 13. He is studying in the Doon School of Dehradun. This is all the information that I have with me about this particular youngman or the Balyogeswar.

A_s to the charge of my hon'ble friend that the activities of this Mission lead to communal disharmony, according to the information with me, this Mission claims to have equal respect for all religions and stresses upon realisation of self through transcendentalism. I have no information to support this contention that they play one people[^] one community against another.

And this very incident is a pointer to the ways in which some of the groups are operating because where there should have been divine light, they seem to have seen no light, as they go and try to attack newspapers which are a little bit oritical of them. I would have expected any religious mission to have the utmost tolerance. On the one hand, they say that they are tolerant towards all religions, but one the other, they do not have eyen the simple tolerance of facing criticism from a newspaper. Sir, if things of this type are allowed to continue, then I suppose any religious group or any group of followers of a vogi could blackmail any newspaper in this country to write things which are favourable to them. So, in the first place this is most reprehensible. At the same time, I should say that the Government is very alert to political demonstrations. I remember when we held a demonstration in April at the Patel Chowk, the police beat us up and used the utmost violence that they could use at that time. But when it comes to a following or group like this, probably there are some people who are involved in it and out of deference to them, the big people the police is inactive. Sir. I would like to know from the Government what their policy is with regard to things of this kind because this has been become a serious menace to our country.

And not only in our country, Sir, there are a lot of yogis going abroad; in every Capital of the world, you will find some Indian yogi calling himself a "Maharishi" or something or the other, and then making a lot of mony. They make a lot of foreign exchange, of jvhich there is no account submitted to the Government. They defraud and cheat the foreigners and this has brought a bad name to our country as a whole. So, I would like the Government to evolve a policy in this regard and see that such cheats are not allowed to besmich the fair name of the country. Sir, another thing that I would like to know is whether some of those yogis are not really doing the work of some foreign governments. There are some missions or groups which operate under various garbs and do some espionage activities within the country. So, all these aspects must be studied by the Government and I want the Government to evolve a policy in this regard. It is very important particularly at this time when the security of the country is threatened.

SHRI K. C. PANT: Sir, the hon Member has rightly taken exceptior to the use of force by the adherent; of this Mission against the newspaper and I have, in fact, used the same wore that he used, that their conduct was "reprehensible". I entirely agree thai it ill behaves a Mission which call; itself a religious body not to hav< tolerence even to stomach the criti-cism of a newspaper. In fact, it wa.' not criticism, it was a press report anc later on the paper itself published thi version given by the Mission also. Sc there is no justification whatsoeve for this conduct. About the polici I think by implication Mr. MurahaT has also commended the conduct o the police in this case. Sir, very interesting replies we are getting. It is said that this Bal Yogi is studying in the Public School in Dehra Dun. He is a divine incarnation according to these people. First of all, I totally disapprove of this kind of thing which happened before the Times of Indian Office. Surely they should be firmly dealt with and these people should not be allowed to do such things. What somewhat disturbs me is the soft attitude on the part of some vogis in the Government who are the fans of these yogis. Just as you have film fans there are yogi fans in the Administration. As you know some Ministers go to the astrologers. Some Ministers go to the Yogis. Naturally the Yogis know it. Here is a government in which Yogi friends are there and may be under their influence no action is taken against the Yogis. I am not necessarily suggesting that Shri Pant is a Yogi friend. Probably he is a Yogi himself. That is a different matter. I am not accusing him of being a fan. The police handled it. But I think preventive action should have been take earlier not to allow them to go near the building. Yogis are after all not a hefeoic people. Their affection for God does not give them enough courage to face some mundane things that we are faced with. I think some such steps should have been taken. I am in agreement with many members who said that many are in the garb of Yogis these days. They are far from God-as far as North Pole is from the South Pole. Yet they masquerade as Yogis because it is a growing profession.- Some of the Americans and others who come here are donning the garb of Yogis and pass on as Yogis. We have got an international Yogi emporium here. They are coming from all parts of the country. Would be Yogis are coming

and joining this holy crowd. should be seriously considered.

Anand Marg is supposed to be an great divine institution serving God. but committing every crime on including rape. What are you earth going to do with them? Action should be taken against them. I do not quite appreciate the attempts to equate this incident with the AICC incident or the Jantar Mantar incident. Nor do I ap preciate the answer given by him. These two cannot be put on the same footing, I agree. The Minister Shri Pant is not only a member of the Congress Party whose banner he must uphold, but he is also an important member of the Government, being the Minister of State in the Ministry of Home Affairs. He should not have said anything which by implication may sound as having endorsed what was done at Jantar Mantar. I do not approve of such actions. You know my feelings about the Jantar Mantar people. They were in illegal occupa tion of this building, I agree. They had no right to claim everything when they were nothing. Really they took possession of this thing after the split of the Congress without any moral political justification. You can campaign against them. But the you entered there to take possession of it was wrong. Besides, you should have known that you are in control of the government in the Centre. This incident took place in the capital under your very nose. This expose you to serious charges would from other well-meaning quarters. You should have known that

SHRI BHUPESH GUPTA: The Congress Party people should know that the Supreme Court judgment will make it a subject-matter of dispute. Now you find that the AICC building is under lock and key. You should have anticipated that. The movent something happens, Shri Sri Rama _ Reddy goes to the Supreme Court " without any reason. During the last

year he made the Supreme Court his abode rather than the Rajya Sabha. Such Supreme Court addicts are here. With such people in these benches, you should have taken care to see that you do not provide a handle to them so that they will go to the Supreme Court and get an injunction. Now everything is under lock and key. And this is the deadlock in Congress thinking and Congress imagination. Do not lose your imagination. You should have anticipated and you should have taken some action and when it c'omes at the administrative level you should condemn such action and control your party members not to do these things in this manner. Do fiot try to emulate them. (Time Bell). I think, Sir, by this they have not done good to themsalves or to the country and I think, Sir, that Mr. Pant should realise as the Home Minister that he should really disapprove the kind of violent action that took place.

MR. DEPUTY CHAIRMAN: All right.

SHRI BHUPESH GUPTA: Just a minute, Sir. It may be somewhat spectacular and it may rouse the feelings of some of your followers and I can understand that in politics such things are necessary. But you are the real party at the Centre and this is the capital of the country and the Supreme Court judgment was there which should have actually prevented you. Now, Sir, I understand that the -employees who have written to you are staging a 'dharma' or, I think, in 'dharna' they want employment and probably you can provide them employment. So, you have bungled in this matter. Be careful in the future and do not do such things.

SHRI K. C. PANT: Sir, if I understand the policy of my hon. friend's party correctly, they believe that in the case of land, the landless people should go and occupy the land.

DR. BHAI MAHAVIR: You are not landless.

SHRI BHUPESH GUPTA: He puts everybody in the same category. Sir, on a point of order. Sir, Shrimati Indira Gandhi, Shri Sanjivayya and Shri K. C. Pant—these are not landless people, either politically or otherwise. Why do you bring in this issue?

MR. DEPUTY CHAIRMAN: All right. Mr. Bhupesh Gupta, please listen.

SHRI BHUPESH GUPTA: If it is your policy, then we shall follow you. You do not take any action in such cases. (Interruptions).

SHRI K. C. PANT: We have taken action...

SHRI GODEY MURAHARI: If he justifies it, we will all go and capture the land.

MR. DEPUTY CHAIRMAN: Please sit

SHRI K. C. PANT: Why don't you listen, Mr. Bhupesh Gupta? You had your say.

SHRI S. G. SARDESAI: Will the Ministers' bungalows also be capture-ed?

SHRI K. C. PANT: Sir, the point that he has missed is that the Government has taken action and will continue to do so. But, Sir, it does not really lie in his mouth to teach us these things. What I was saying was that it is not in conformity with what he preaches elsewhere ... (Inter-ruptions).

SHRI BHUPESH GUPTA: No, Sir...
