(b) The survey covered 5 industries in Asansol region and 3 industries in Durgapur region. The Durgapur Ther-

mal Power Station was also surveyed in addition. Out of 8 industries surveyed, 2 are iron and steel industries, 3 chemical industries, 1 distillery, 1 engineering and 1 pulp and paper industry. The survey revealed that about 1,59,100 cubic metres of waste water having +3,100 kilograms Bio-chemical Oxygen Demand is produced per day from these industries and the effluents also contain toxic compounds, such as cyanides, phenols, ammonia etc. Three out of these 8 industries had facilities for partial treatment of wastes although their performance was not considered satisfactory.

(c) The Damodar Valley Corporation held a meeting with the representatives of the concerned industries in February 1970 and these industries agreed to take remedial measures to minimise the pollution.

As a general measure to control the problem of water pollution Government have introduced legislation in the Parliament which would provide an effective check against this problem.
