(ख) और (ग) 1971 की जनगणना के
आधार पर धर्मवार आंकड़े अभी उपलब्ध
नहीं हैं। अतः यह बताना संभव नहीं है कि
1961 से 1971 तक की अवधि में किस किस
समुदाय में प्रतिशत वृद्धि या कमी हुई है।
तथापि 1951 और 1961 की जनगणना
के अनुसार प्रमुख समुदायों की जनसंख्या
कुल जनसंख्या की तुलना में उनका प्रतिशत
और 1951-61 के दशक में जनसंख्या
में हुई प्रतिशत वृद्धि का एक विवरण अनुपत्र
में दिया गया है। [देखिए परिशिष्ट 78
अनुपत्र संख्या 8] यह सही नहीं है कि 1951-
61 के दशक में जनसंख्या में हिन्दूओं का
प्रतिशत पर्याप्त मात्रा में कम हुआ है।

(a) A statement showing Family Planning performance in sterilization/IUCD insertions and Conventional Contraceptive users for the year 1968-69, 1969-70 and 1970-71 is shown in the Enclosure

Community-wise statistics regarding acceptance of the Family Planning Programme on State/all-India basis are not maintained. However, some *ad hoc* studies have been conducted and the results of such studies have been compiled. These are shown in the enclosure (A, B and C) [See Appendix LXXVIII, Annexure No. 7]

(b) and (c) The religion-wise data on the basis of 1971 census is not yet available, it is, therefore, not possible to say which community has a percentage increase or decrease in the period 1961-71. However, a statement showing population of major communities according to the 1951 and 1961 census, their percentage to total population and percentage increase in the population during the decade 1951-61 is shown in the enclosure [See Appendix LXXVIII, Annexure No. 8]. It is not a fact that percentage of Hindus in the population has considerably gone down in the decade 1951-61.

The above figures include expenditure on the Rashtrapati Bhavan and the establishments at Bolarum (Hyderabad) and Mashobra (Simla). This expenditure includes, besides taxes, the cost of ancillary services such as electric sub-stations, air-conditioning units, fire fighting equipment, electricity and water consumption etc which vary from year to year and which are not susceptible of strict apportionment.

DROUGHT IN ANDHRA PRADESH
