(a) Yes Sir.

(b) and (c) The State Government¹ have taken steps to give relief through employment to flood affected agricultural labourers by starting relief works wherever possible and a sum of Rupees Twenty lakhs Seventy five thousand has already been sanctioned for the purpose. Besides, an emergency programme for rabi cultivation on sixteen lakh acres has been taken and State Government has already sanctioned rupees two crores eighty four lakhs

and fifty five thousand for distribution as agricultural loans to affected agriculturists for purchase of seeds. Agricultural labourers will be directly benefitted from this.

(d) Yes, Sir, The State Government assessed that kharif crops on more than twenty six lakh acres were damaged by floods. Agricultural labourers who would have been engaged in various operations such as sowing, interculture, weeding and harvesting were affected as a result of the floods.

(b) if so, what steps have been taken by the Calcutta Metropolitan Development Authority to increase the capacity of the water supply in Calcutta?

THE MINISTER OF HEALTH AND FAMILY PLANNING/स्वास्थ्य और परिवार नियोजन मंत्री (SHRI UMA SHANKAR DIKSHIT) : (a) Yes Sir.

(b) The Calcutta Metropolitan Development Authority has taken up 24 schemes estimated to cost Rs. 42 crores. A provision of Rs. 33 crores has been made for these schemes during the Fourth Five-Year Plan period. Three of these schemes have been completed, one is nearing completion and the remaining schemes are at various stages of implementation. The 60-million gallon plant at Palta has been commissioned recently which enables the per capita water supply in Calcutta to be raised to 50 gallons per day. 16 tubs-wells have been commissioned raising per capita supply to 20 gallons per day in ToUygunj area. When all the schemes are implemented, it would be possible to supply water at the rate of 60 gallons per capita per day in Calcutta, 40 gallons in Hjrurah and 20 gallons in other Municipal and non-Municipal urban areas.
