

Technical School was set up in 1968 and the classes started in 1966. Since 1968 there have been no students and the State Government is considering the question of closing down the school.

(c) and (d) The State Government has given so far a grant of Rs. 47,500/- for furniture, equipment etc. The Governing Body of the School could not get electrical power from the State Electricity Board, nor did it approach the State Government for purchase of a separate generator. Training was given only in those trades which did not require electrical power.

(e) The Scheme of Junior Technical Schools provides for the award of stipend to 50 per cent of the students when the schools are fully developed. This provision, however, could not be made applicable to the Laudoha Technical School since it was still undeveloped.

ERADICATION OF FAMINE CONDITIONS IN ANDHRA PRADESH

838. SHRI SANDA NARAYANA-PPA : Will the Minister of AGRICULTURE, कृषि मंत्री be pleased to state :

(a) what are the various steps taken by the Government of India to eradicate the drought and famine conditions in Rayalaseema area in Andhra Pradesh on permanent basis upto-date;

(b) whether any proposals have been sent by the Rayalaseema Development Board to Government in this connection;

(c) whether the Government of Andhra Pradesh has recommended those proposals ; and

(d) if so, the action taken thereon by Government ?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE/ कृषि मंत्रालय में राज्य मंत्री (PROF. SHER SINGH) : (a) Four districts, namely, Anantapur, Kunrool, Cuddappah & Chittoor have been selected in Rayalaseema area in Andhra Pradesh in consultation with the State Government for coverage under the Rural Works Programme which seeks to mitigate the severity of droughts in the hard-core drought prone areas of the country, under the programme the allocation for each dis-

trict is Rs. 2 crores during the Fourth Plan period.

(b) and (c) Draft Master Plans for the above mentioned four districts, outlining the programme to be taken up during the Fourth Plan period, have been received. Presumably, the State Government have taken into account all factors, including the views of the Rayalaseema Development Board, in formulating these Master Plans.

(d) The Draft Master Plans are being examined.
