(a) whether it is a fact that many States have failed to enforce the provisions of the Indian Pharmacy Act; and if so, which are those States; and

(b) how many qualified pharmacists are at work in the various chemists shops all over the country at the present time ?

स्वास्थ्य और परिवार नियोजन मंत्रालय में राज्य मंत्री (Pradesh and Delhi have enforced all the provisions of the Pharmacy Act, 1948. A statement giving the detailed information in regard to enforcement of various provisions of the Act by the State Governments is attached. [See Appendix LXXVIII, Annexure No. 5].

(b) According to the information received from State Governments of West Bengal, Gujarat, Mysore, Bihar, Chandigarh Administration, Manipur, Tripura, Dadra and Nagar Haveli, Delhi Administration, Goa, Daman & Diu, Laccadive & Minicoy Islands, Andamans, Port Blair and Pondicherry, the number of qualified pharmacists at work is 15,861. The State Governments of Uttar Pradesh, Maharashtra, Bihar and Himachal Pradesh have stated that information is not readily available with them. The remaining State Governments have yet to report.
