## STATEMENT

As a result of the bumper coffee crop in 1970-71, the planters may experience difficulties regarding payments on coffee delivered by them to the Coffee Board. The payments made and arranged to be made so far on this crop amount to Rs. 3/- per point as against the basic reserve price of Rs. 3.10 per point. of a total quantity of 1,09,251 tonnes received into the pool from this crop, 69,775 tonnes have already been disposed of as on 1st November, 1971 leaving a balance stock of 39,476 tonnes. Out of this balance stock, a quantity of 14,736 tonnes is yet to be sold for export against an allocation of 53,000 tonnes fixed for export by the Board. It is proposed that the balance of 23,740 tonnes will be utilised for releases in internal market during November and December, 1971 and for carry-over to 1972.

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION POWER/सिचाई श्रौर विधत मंत्रालय में उपमंती NAŤĤ (SHRI BAIJ KUREEL):

- (a) The India Meteorological Department issued warning of a cyclonic storm expected to affect the coastal districts of West Bengal and North Orissa by high priority telegram to the Chief Secretary, Orissa Government and the district Collectors of Balasore and Cuttack at 12,20 hours (1.S.T.) on October 29 and to All-India Radio, Cuttack and Sambalpur at 16.30 hours (I.S.I.) October 29.
- (b) The assessment of the damage caused by the cyclone is being done by the State Government. According to preliminary reports an area of 2.5 lakh was affected of which cropped area was 30 to 50 percent. The loss of life is estimated between 9000 and 10,000. About 7 lakhs thatched huts collapsed.

The Army helped in the relief operations. The Central Government sent some planes for air dropping of food for the areas not accessible by roads. An
