OFFICE BUILDINGS IN THE CAPITAL

192. SHRI N. R. MUNISWAMY : Will the Minister of WORKS AND HOUSING/निर्माण और आवास मन्त्री be pleased to state

(a) whether it is a fact that various Government office buildings constructed in New Delhi would outlive its utility in 30-40 years which is too less a period as compared to the buildings constructed before independence.

(b) the actual cost of construction of Krishi Bhawan, Rail Bhawan, Transport Bhawan, Udyog Bhawan, Ninnan Bhawan, Vayu Bhawan, Vigyan Bhawan, Yojana Bhawan, "Akashwani" L. I. C. Building in Parliament Street and Alipore Road, Reserve Bank Buildings and Dak Ghar Bhawan along with date of completion of construction ;

(c) the yearly depreciated value of each of the buildings mentioned in part (b) above;

(d) the present value of each of them; and

(e) the annual expenditure on main tenance and repairs during the last three years?

(SHRI I. K. GUJRAL): (&) No, sir. The life of permanent Government office buildings in New Delhi is assessed as 10 J years.

(b) The information about the Rail Bhawan, L. I. C. Buildings on Parliament street and Alipore Road, Reserve Bank Buildings and Dak Ghar Bhawan, is not available with this Ministry as the same are not being maintained by this Ministry. This information is being collected and will be placed on the Table of the House-

(c) The depreciated value of a building is worked out in a particular year on the basis of the cost of constructing a similar building during that year, the age of the building and its expected residual life. It would thus be seen that the yearly depreciated value of a building varies from year to year.
