#### INDUSTRIALISATION OF NORTH BENGAL DISTRICTS

(a) whether the Government of West Bengal have submitted any specific proposal for the industrialisation of the North Bengal Districts,

(b) if so, the details of the proposal,

(c) the decision taken by Government thereon

(d) whether Government propose to set up any industrial unit under the Public Sector in North Bengal, and

(e) if so, the details thereof?

(SHRI GHANSHYAM OZA) (a) to (e)

The State Government is carrying out a survey of each district from the point of view of identifying industries suited to the local area based largely on local raw materials and skills. Targets have been set for the establishment of small industrial units in the region. To start with, the State Government proposes to promote the setting up of 375 small scale units per year in the districts of North Bengal. The State Government has taken a decision to encourage industries of a permanent nature, particularly those based on the supply of materials from forest and agricultural resources, in the backward districts of the

State. After studying the resources available, the State Government is of the view that a medium sized paper mill and a particle board factory, based on the supply of timber from the forests of North Bengal as also from the adjoining areas, can be set up. A unit for the preservation of fruits can also be established. Efforts are being made to persuade prospective entrepreneurs to bring up schemes on these lines.

The West Bengal Industrial Development Corporation has submitted a proposal for a watch manufacturing unit in the public sector in North Bengal. There is at present no proposal in view for the setting up of a Central Public Sector Unit in North Bengal.

#### CRISIS IN FILM INDUSTRY IN WEST BENGAL

(a) whether Government's attention has been drawn to reports of acute crisis in the Bengali film industry in West Bengal and

(b) if so what steps Government propose to take to help the industry to face this crisis?

(SHRI DHARAMVIR SINGH) (a) Yes, Sir.

(b) Enquiries have been made from the State Government, who have informed the Central Government that this crisis has been engaging their attention for some years. State Government had appointed a Film Enquiry Committee under the Chairmanship of Justice K. C. Sen in 1962. Another *Ad hoc* Committee headed by Shri R. Gupta was set up in 1966 by the State Government. The reports of both these Committees were published in 1968.

In June, 1969 a State Film Consultative Committee was appointed by the State Government consisting of representatives of all sectors of the film industry. This Committee was entrusted with the task of suggesting

methods for implementing different recommendations of the previous committees as also making new recommendations, if any, in view of the changing situation. Its report containing various measures for improvement of the industry is now under consideration of the State Government.

#### FOREIGN NATIONALS IN INDIA

229. SHRI M. K. MOHTA : Will the Minister of HOME AFFAIRS/ गृह मंत्री be pleased to state:

(a) the number of foreign nationals, who have been staying in India for a long time and are now seeking Indian nationality;

(b) the number of such persons who have been given Indian nationality during the last one year;

(c) the guiding principles in granting Indian nationality to foreign nationals; and

(d) the number of persons who have been refused Indian nationality?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS/ गृह मंत्रालय में राज्य मंत्री ( SHRI K. C. PANT ) : (a) As on 10th November, 1971 the Central Government had before them 38 applications for grant of Indian citizenship. These are under consideration.

(b) According to the information available, 1542 persons of Indian origin were registered as Indian citizens under section 5 (1) (a)/(d) of the Citizenship Act, 1955, by the Collectors in the Districts during the period from 1.7.1970 to 30.6.1971. Besides, 301 foreigners were granted Indian citizenship by registration under section 5 (1) (c), and naturalisation under section 6 (1), of the Citizenship Act, 1955 by the Central Government during the same period.

(c) Citizenship is granted to the foreign nationals in accordance with the provisions of the Citizenship Act, 1955 and the Citizenship Rules, 1956.

(d) Statistics have not been maintained. The information is, therefore, not available.

#### KILLINGS BY NAXALITES IN PUNJAB

(a) According to information received from the State Government, ten persons have been killed in Punjab by the Naxalites since imposition of Presidential rule.

(b) Four arrests have been made in connection with these murders.

(c) Cases are still under investigation.
