ARREST OF PAK AGENTS

(a) whether it is a fact that in the month of August 1971, about 400 trained Pakistani agents were rounded up in Assam and Meghalaya since the influx of evacuees from Bangla Desh, and

(b) what are the details of the round-up of these agents who have infiltrated into India?

Amongst the arrested persons, one Pak national and 4 Indian nationals were believed to have been trained by the Pak Army in espionage/sabotage.

(a) whether it is a fact that Mrs. Ayesha Sheikh, the newly nominated Member of the New Delhi Municipal Committee, had recently lodged a complaint with the Hauzkhass Police Station, Delhi regarding the harassment and threat given by some persons of her locality to kill her two children;

(b) if so, the details of her complaint; and

(c) the action taken by Government in the matter ?

में राज्य मंत्री (SHRI K. C. PANT): (a) Yes, Sir. She made two complaints regarding harassment and defamation but not of threat to kill her children.

(b) Copies of her complaints are enclosed at Appendix 'A' and 'B'.

(c) Action u/s 107 Cr. P. C. against her tenant was initiated and a case vide FIR No. 344 u/s 506 IPC was also registered at Hauzkhass Police Station on 11.9.1971 for intimidation and harassment which is under investigation. Plain clothes policemen have been detailed for the safety of her children. The Beat Constables and the Division Officer of the area have also been directed to keep a close watch on the situation. Inquiries regarding the origin of the letter could not establish its source nor its sender. Inquiry regarding the source and author of the hand-bill is continuing.

Sir,

Most respectfully I have to state that there are some irresponsible persons, who are trying to blackmail and cause harm to my reputation by sending me false and defamatory letter or by distributing handbills falsely published in my name with some ulterior motives. I am

owner of house No. C. 4/137, Safdar Jang Residential Area, New Delhi. I have a tenant named Shri Man Mohan Singh on the ground floor. He has brought other sub-tenants Shri Devender Singh, Shri Gian Singh and Shri Jagmohan Singh. According to rent deed Mr. Man Mohan Singh is only my tenant. By bringing others in my house, he has turned my house into a boarding house and all these people cause nuisance to me in various ways. I am living in the house above with my two small daughters and a small boy my ward. My husband Major K. Smar Sheikh Vr. C. laid down his life fighting against Pakistan aggression in 1965 at Sialkot Sector. They also happened to maltreat my children on many occasions thus my relations became strained and I give them notice to vacate my house on July 16, 1971. Soon after I had received a letter dated 19th July, 1971 purported to have been written by S. A. Hussain, Second Secretary, Pakistan High Commission, New Delhi informing that there was an important assignment for me for which I shall be richly awarded. I apprehend that Shri Man Mohan Singh and his subtenants were behind the authorship of this letter. Now handbills have been distributed in the locality of C-4 S. D. Area and these handbills have been distributed to defame me in the locality and to force me to leave my house. The handbills are as under :—
