(a) and (b) In a letter to the Prime Minister, Shri Amrit Nahata has stated that Muslims in the Border areas of Rajasthan have been subjected to persistent harassment and pinpricks from the bureaucracy, that dozens of their mosques have been demolished and that hundreds of them have been detained and implicated in false cases. He has also referred to a sense of helplessness and insecurity which has gripped the minds of Muslims in the border areas

(c) The matter had been taken up with the Government of Rajasthan. They have reported, according to information available with them, only one mosque has been demolished because it had been constructed without the permission under the Rajasthan Religious Buildings and Places Act, 1954. The Border Commissioner has, however, been directed to inquire into the allegation regarding the demolition of a mosque. The State Government have further pointed out that the other allegations in the letter are not borne out by facts and no harassment has been caused to the Muslims.
