**B. G. AND M. G. SCRAP DEPOT FOR KERALA**

- (a) whether it is a fact that the trade and industry circle in Kerala has requested Government to open a B. G. and M. G. Scrap Depot in Ernakulam for the sale of condemned rails, sleepers and other scrap materials of the railways; and
- (b) if so, the reaction of Government thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS/रेल मंत्रालय में उप मंत्री (SHRI MOHD. SHAFI QURE-SHI) : (a) No. A suggestion was, however,

made by the Honorary Secretary, Member (Divisional Railway Users' Consultative Committee (Madurai) to this effect.

- (b) No proposal has yet been finalised for opening more Scrap Depots. However, before finalising the location of such Scrap Depots, factors such as arisings of scrap, marketability of scrap in the nearby area etc. will be considered.

**PURULIA-KOTSHILA RAILWAY LINE**

- (a) whether Government have since received the report of the investigation committee which was appointed to go into the question of converting Puilulia-Kotshyila railway line into broad gauge; and
- (b) if so, what are the details in this regard ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS/रेल मंत्रालय में उप मंत्री (SHRI MOHD. SHAFI QURE-SHI) : (a) Yes.

- (b) Based on the recommendations of the Uneconomic Branch Lines Committee, 1969, a detailed traffic survey for the conversion of the Purulia-Kotshila Narrow Gauge line to Broad Gauge was ordered in September, 1970 and the survey is in progress. A decision regarding conversion of the section will be taken after the survey is completed and the results thereof become known.
