(SHRI D. P. YADAV): (a) and (b) Yes, Sir. The Committee submitted its report in June, 1970.

(c) The main recommendations of the Committee are given in the statement attached.

STATEMENT

The Committee submitted a majority report. The main recommendations contained in the report are as follows:

- (i) All polytechnics and Junior Technical Schools should be taken over by the State Government and transformed into full-fledged Government institution sto bring about uniformity in service conditions.
- (ii) All these institutions should be placed under the administrative control of a separate Directorate of Technical Education that should be responsible for recruitment of staff through the State Public Service Commission, framing of service conditions for the employees and formulation of syllabus, conduct of examinations etc.
- (iii) Each institution should have a separate Advisory Council consisting of the Principal, Heads of Departments, representatives of staff and students and local representatives like MLA, Chairman of Municipality etc. The functions of the Council will be to advise the Principal on all academic, administrative and financial matters relating to the institution.
- (iv) Only Higher Secondary passed students should be admitted to the first-year class in polytechnics and the syllabus for Science subjects should be up-graded to the standard of B.Sc. pass course.
- (v) Polytechnic diploma should be recognised as equivalent to B,Sc. pass degree and the Junior Technical School Cerificate as equivalent to Higher Secondary Certificate in Technical stream.
- (vi) A committee should be formed to reorient the courses and syllabus. Practical training programmes should be such as would promote self-employment.
- (vii) Facilities for compulsory vacational training for all polytechnic students during their course of study should be made available.
- (viii) Wherever possible, sandwich course should be introduced and part-time degree courses for diploma holders should be introduc-

- ed in more engineering colleges, specially in industrial areas.
- (ix) More scholarships and other forms of financial assistance should be provided for polytechnic students. Financial assistance should also be extended for visits to industry to get acquainted with the actual working of industry.
- (x) Polytechnic and Junior Technical School courses should be joboriented and provision should be made for specialised training in various subjects.
- (xi) Steps should be taken by the Government for the employment of diploma holders by Government contractors and by the Government Motor Vehicles Inspection Department.
- (xii) The Directorate of Technical Education should make separate arrangements to publicise vacancies.
