ed expenditure in regard to the Agriculture, Irrigation and Power sectors exceeds the Plan provision by about Rs. 206 crores. As against this the performance in respect of Industry, Transport, Social Services and other programmes shows that expenditure in the first two years falls short of the provision by about Rs. 353 crores.

While these figures are not final, the Planning Commission is engaged in a midterm appraisal, to review the current position and assess the outlook for the future. In this connection, the Deputy Chairman has written letters to Central Ministers and Chief Ministers/Governors of States and Union Territories asking them to review the implementation of Plan schemes. He has also highlighted the short-falls and indicated the areas that call for improvement- Discussions are now being held in the Planning Commission with the representatives of the Central Ministries, State Governments and Union Territories. The exercise on the midterm Appraisal is expected to be over soon.

(b) The Scientists' Pool has been in operation since 1959 for temporary placement of well qualified Scientists, Technologists and Medical Personnel specially for those India without assured returning to employment. Those qualified in Social Sciences and Humanities were later included. As on 1-11-71 there were 344 persons working in the Scientists' Pool. They are attached to suitable organisations where they could carry out teaching, research, consultancy. design, development, Professional practice etc., according to their qualifications experience.
