(b) These countries are displaying a greater awareness of the developments in Bangla Desh and of the refugee problem, as would be evident from the endorsement of paragraph 7 of the Joint Communique of the Consultative Committee meeting of the Non-aligned countries at the Foreign Ministers' level which called for effective international action to brir about a political solution
