SHRI C. D. PANDE (Uttar Pradesh): Sir, I am really constrained to observe that the Government has not taken the whole question very seriously. The matter has been diverted to a lower key. The real question is whether the Government is in a position to detect any overflight of our space. If you have failed in that it is your du'y, not (he duty of the Government of Bihar to whom you are referring again and again. The emphasis of the Minister is on the contents of the balloons. There was literature, there were pictures of Chiang-Kai-Shek in them and therefore they were harmless. They could have contained pictures of Chain-Kai-Shek, they could have contained bombs also. They can come from Taiwan and they could come from Peking also. The whole thing is whether the Government is serious about checking any intrusion into our air space. And my opinion is that you have completely failed in making a proper guard of our air space. You are emphasising that there is nothing dangerous. Then, I ask: What was the purpose in sending these? Was it only meteorological? May I also know if there were other parties also in the land of Bihar who were waiting for that balloon, those in whose hands that balloon fell? Who were the beneficiaries of the things that contained in that balloon? These are the questions and there must have been some conspiracy with foreign countries. Therefore, the Government should come forward with detailed information as to how these things are happening year after year and they are .inable to detect the violation of our air space.

SHRI RAM NIWAS MIRDHA: The hon'ble Member' has raised a lot of things.

There is no question of the Government being complacent on this matter. At the same time I would like to state very clearly that we need not take a very alarmist and sensational view, as some hon'ble Members have taken in this matter. We should not read things which do not exist. There is no question of any sinister conspiracy, namely, somebody waiting on the ground in the forests for something to fall from the sky or trying to cook up things of that nature. We certainly are not complacent. At the same time the Government certainy does not share the alarmist view that the hon'ble Member is taking.
