(ii) Upper age limit for entry into Government services has been relaxed by 5 years for recruitment to class III and IV posts in Central Government.

New Projects

- 1. The Sheltered Workshop of the National Centre for the Blind is proposed to be expanded in the current year.
- 2. A Centre for Training Instructions of the Blind in Orientation and Mobility is to be set up as part of the National Centre for the Blind in the current year.
- 3. An agricultural section is to be added to the National Centre for the Blind.
- 4. A building for the National Library for the Blind is proposed to be put up at the National Centre.
- 5. The income tax exemption limit for totally blind persons has been raised to Rs. 10,000.
- 6. Subject to certain conditions, fees paid by the parents of blind children to approved educational institutions will be reimbursed to the Central Government employees.
- 7. A project to place blind children in Delhi in regular schools for sighted children is being initiated in the current year.
