from Rs. 50 to Rs. 80 per 1000 cubic metres of gas and to this would be added a premium of Rs. 26 to recoup the under-recoveries on well-head price for the past supplies bringing the revised well-head price to Rs. 106 per 1,000 cubic metres. In addition there will be charges on account of royalty and sales tax and on account of transportation where also a premium will be added to recoup past under-recoveries and this will differ from consumer to consumer.

- (b) Yes. Sir.
- (c) and (d) The Award of Dr. V.K.R.V. Rao on Price of Ankleshwar/Cambay Gas stipulated that a new price be fixed for gas after 31-3-1971 for the next five years after undertaking a thorough review of the actual position regarding output, outlay and demand during the period covered by the Award. In terms of this Award the Oil and Natural Gas Commission undertook such a review and wrote to the various consumers indicating the new price formulated and requesting for their concurrence. Discussions between the Oil and Natural Gas Commission and the consumers are still continuing.]

- (a) whether it is a fact that about four months back an aircraft of the Defence Services which took off from the Gorakhpur aerodrome, crashed in Sevai village, about five miles from the aerodrome;
- (b) whether the accident occurred due to mechanical defects in the plane or due to some other reasons;
- (c) the details of the losses caused to life and property due to this accident; and
- (d) whether any remedial steps have been taken by Government to avert such accidents in civilian areas?]

- (ग) दुर्धटना के परिणाम स्वरूप पाइलट फ्लाइंग अफसर एस० टी० पोवर की मृत्यु हो गई थी। विमान पूरी तरह से नष्ट हो गया था। सेवई गांव के श्री केशव प्रसाद सिंह की 500 रु० के लगभग की खड़ी फसल नष्ट हो गई थी।
- (घ) नागरिक क्षेत्रों के ऊपर से उड़ानों को नियंत्रित करने के लिए पहले से ही अनुदेश हैं।

- (e) Projects have so far been received by the Corporation from the States of States of the Andhra Pradesh, Gujarat, Kerala, Mysore, Madhya Pradesh, Maharashtra, Rajasthan, Tamil Nadu, Uttar Pradesh, West Bengal, Punjab, Haryana, Himachal Pradesh, Goa, Daman and Diu and Pondicherry. These projects envisage a total investment of over Rs. 500 crores including a seed capital of about Rs. 140 crores required from the Housing and Urban Development Finance Corporation.
