(b) It has been decided that the existing statutory obligation of the mills to produce controlled cloth to the extent of 25% of their production should not be altered. A scheme has recently been evolved in consultation with the industry whereby the industry has undertaken to produce 100 million sq. metres of controlled cloth during 3 months beginning from 1st June, 1971.

The mills which produce controlled varieties of cloth will be given a subsidy to the extent of 50 paise per sq. metre from Funds which will be collected by the industry.

(b) One tea garden was closed down due to uneconomic working ; another tea garden was requisitioned for defence purposes and the third garden which was closed down due to uneconomic working had been resumed by the West Bengal Government under the Estates Acquisition Act.

(c) There is no proposal under consideration to reopen the closed tea garden.

Excepting the above, the Government of India have not evolved a national energy policy as such.
