(a) and (b) The achievement in the case of cotton has generally lagged behind the target. This may be attributed mainly to concentration of the crop in rain-fed areas involving relatively greater risk and uncertainty about crop output thereby inhibiting the farmer to invest, lack of varietal break-through, etc.

(c) Steps have been taken to increase the production of cotton by adoption of intensive cultivation measures on the lines of package programme in the potential areas. Research scientists have been working on Coordinated Projects to evolve varieties which among other things will give high yields.
