- 10-12 December, 1970 and had discussions with the Chairman and Member (Agri.), Planning Commission. Ministry of Agriculture are not aware of any meeting had by the Committee with other heads of several U. N. Agency Missions in India.
- (b) The purpose of the visit of the Committee was to interview distinguished social Scientists, Politicians, Administrators and policy framers in India to get a first hand view of the latest developments in India in the field of Agrarian Reform.
- (c) The discussions centred around the progress of various aspects of Land Reform and agricultural credit in India. The Members of the Committee were apprised of the latest developments in these fields in India.

INSTALLED CAPACITY IN THREE PUBLIC SECTOR STEEL PLANTS

*278. DR. K. MATHEW KURIAN: Will the Minister of STEEL AND MINES /इस्पात और खान मंत्री be pleased to state:

- (a) the percentage utilisation of installed capacity in the three public sector steel plants at Durgapur, Rourkela and Bhilai in 1970-71 as compared to the previous year 1969-70;
- (b) whether any effective step has been taken by Government to ensure fuller utilisation of capacity in these plants; and
 - (c) if so, the details thereof?

THE MINISTER OF STEEL AND MINES /इस्पात और खान मंत्री (SHRI KUMARAMANGA-MOHAN LAM): (a) to (c) A statement is placed on the Table of the House.

STATEMENT

- (a) In terms of Steel ingot, the production during 1970-71 at Bhilai, Rourkela and Durgapur Steel Plants was to the extent of 77.6%, 57.7% and 39.6% of installed capacity. The corresponding figures for 1969-70 were 74.4%, 61.3% and 51.1.%
- (b) and (c) Within the limitations imposed by the industrial relations situation, the Management of Hindustan Steel Limited is concentrating on all possible efforts to raise production to significantly higher levels as rapidly as

possible. These include improved maintenance of plant and equipment, procurement of spares, refractories, locos and other essential materials, speeding up of capital programmes required to correct imbalances in production facilities, introduction of technological improvements etc. Efforts are also being made to improve industrial relations by trying to resolve industrial disputes by mutual discussions as far as possible. A revised incentive scheme has also been evolved with a view to encouraging higher production and productivity. The revised scheme has been introduced in most of the important Units of the Bhilai Steel Plant and in some of the Units of the other two plants, in consultation with the Unions and it is proposed to extend this scheme to the remaining units in due course.

MOHAN KUMARAMANGALAM): (a) As a result of investigations conducted by the Geological Survey of India in the Barmer district of Rajasthan, reserves of the order of 85 lakh tonnes of Bentonite and 8 crores 50 lakh tonnes of Fuller's earth have been proved. Reserves of gypsite have also been located. These minerals are being partly exploited at present

(b) As this matter relates to the State Government, the information has been called for from them and will be placed on the Table of the House when received.

(c) It is understood that the Rajasthan Industrial and Mineral Development Corporation are carrying out studies about the possibility of setting up of an activisation plant for Bentonite deposits in Barmer District. Fuller information has been called for about this also and will be laid on the Table of the House on receipt.]

MOHAN KUMARAMANGA-LAM): (a) Amount of stowing assistance paid to coal mines owned by the Jourteen Industrial Houses in 1970-71 total Rs. 220 60 lakhs constituting 38%, of the total assistance to collieries. Similarly, assistance for adverse factors paid to these companies totals Rs. 81 26 lakhs constituting 51% of the total to all collieries.

- (b) Three Statements A to C g ving the relevant information are laid or the Table of the House.
- (c) Eligibility for subsidies is governed by the provisions of the Coal Mines (Conservation Safety and Development) Act, 1952 and the Rules framed thereunder and payment of subsidies are made at the rates prescribed by the Central Government as provided in the Coal Mines (Conservation & Safety) Rules, 1954.
