: (a) and (b) No water from river Ravi has been flowing to Pakistan except during the monsoon months when surplus flood waters, over and above the requirements of India, flow down to Pakistan.

Proposals for a storage dam on Ravi are already under consideration so as to reduce the waters flowing to Pakistan to the maximum extent possible.
