A copy of the terms of reference of the Committee is attached. They cover the question of grant of interim relief to the categories of officers covered by its terms of reference, pending the submission of final report.

## Terms of Reference

To enquire into and make recommendations on the scales of pay and allowances of (i) Class I and Class II officers of services other than marine services under the Commissioners for the Port of Calcutta and the Trusts administering the other major ports and (ii) Class I and Class II officers of Dock Labour Boards at the major ports.

The Committee may also consider and make recommendation on the question of grant of any interim relief to the categories of officers covered by its terms of reference, pending the submission of its final report.

The Committee is requested to have regard, while making its recommendations, to the economic conditions in the country, the resources of the Ports, the demands thereon, such as those on account of developmental planning and the repercussions the recommendations may have on employers of similar personnel in the public sector.

The Committee will make its recommendations as soon as possible.

Note.—The posts of Chairman of the Major Port Trusts and of the Calcutta Port Commissioners and the posts of Deputy Chairman, Calcutta Port Commissioners, and the General Manager of the Bombay Port Trust will be outside the purview of the Committee.
