

**वित्त मंत्री (श्री य० ब० चव्हाण) :** (क) बैंक, जमाकर्ताओं का वर्गीकरण इस प्रकार नहीं करते हैं जैसा कि प्रश्न में मान लिया गया है। बिहार में राष्ट्रीय-कृत बैंकों में सितम्बर, 1970 के अन्त में 85 करोड़ रुपये जमा थे।

(ख) ऋणकर्ताओं का वर्गीकरण भी इस प्रकार नहीं किया जाता जैसा कि प्रश्न में पूछा गया है। फिर भी कृषि, लघु उद्योग, खुदरा व्यापारी, सड़क परिवहन, पेशेवर और ग्राम-नियोजित व्यक्ति, छोटे व्यवसाय शीर्षकों के अन्तर्गत और शिक्षा के प्रयोजनों के लिये बिहार में 14 राष्ट्रीयकृत बैंकों द्वारा किये गये ऋणों की बकाया रकम दिसम्बर, 1970 के अन्त में 9.8 करोड़ रुपये थी।

†[THE MINISTER OF FINANCE/वित्त मंत्री (SHRI Y. B. CHAVAN): (a) Depositors are not classified by the banks in the manner assumed in the question. Deposits with the offices of the nationalised banks in Bihar were of the order of Rs. 85 crores as at the end of September, 1970.

(b) Borrowers also are not categorised in the manner indicated in the question. However, the outstanding amount of advances by the 14 nationalised banks in Bihar under the heads, agriculture, small scale industry, retail traders, road transport, professional and self-employed persons, small business and for purposes of education amounted to about Rs. 9.8 crores at the end of December, 1970.]
