in toto by the Government The production of electronic items, both equipment and components, which was Rs 30.5 crores in 1964-65 has risen to Rs 175 crores in 1970-71. This may be compared to the Bhabha. Committee's target of Rs 384 crores for being achieved in 1975. The National Conference on Flectronics held in Bombay in March last year noted that there was large growth in consumer electronics but shortfalls in the defence and communication fields.

Realising the need for faster development of electronics in the country, so as to achieve self-reliance and self-sufficiency in the shortest possible manner, Government have set up the Flectronics Commission with full executive and financial powers. The Commission will review the entire field of electronics with regard to research, development and industrial operations, formulate policy in this field and direct the implementation of all measures both promotional and regulatory, on sound technical and economic principles

The Flectronics Commission in accordance with its above mandate is undertaking the preparation of a new programme for development of electronics in all its aspects
