MINISTER OF SUPPLY/ पति मंत्री (SHRI D. R. CHAVAN): (a) to (c) Contracts were placed for the supply of 3.75,470 bales of B Twill bags during the period January, 1970 to March, 1971 at a provisional price of Rs. 200 per 100 bags with excise duty and sales tax extra subject to adjustment on the basis of the fair selling price to be fixed by the Government on the recommendations of the Tariff Commission.

A statement *[see Appendix LXXVI]*, Annexure No. 54) showing the mill-wise placement of orders, quantities' supplied by them and those outstanding with them on 4-6-71 is placed on the Table of the House.

Government have, however, set up a Billet-Re-rollers' Committee for the purpose of regulating the production and distribution of materials rolled by billet re-rollers. Copies of the relevant notifications outlining the salient features have been given earlier to the House.

The operation of the Billet Re-| rollers' Committee does add to i steel not availability in the country, but increases the proportion available for regulated distribution to priority sectors at regulated prices.
