#### LOSS IN COOPERATIVE STORES

(a) whether Government's attention has been drawn to a news item published in the Hindustan Times of the 1st May, 1971 to the effect that the main causes for the loss to the Cooperative Stores according to the All India Conference of the Additional and Joint

Registrars of Cooperative Consumers Societies and the Chief Executive officers of the Stores, have been inefficient management and top heavy overhead expenditure; and

(b) if so, the Government's reaction thereto ?]

कृषि मंत्रालय में उप मंत्री (श्री जगन्नाथ पहाड़िया) : (क) जी हाँ, इस रिपोर्ट में सहकारी भण्डारों को हुई हानि के मुख्य कारण कुशल प्रबन्ध का अभाव और भारी ऊपरी व्यय दिए गए हैं और अन्य कारणों का भी उल्लेख किया गया है।

(ख) सरकार को उपभोक्ता सहकारी समितियों के कार्यकरण में इनकी तथा अन्य त्रुटियों की जानकारी है। इस सम्मेलन ने उपभोक्ता सहकारी समितियों के कार्यकरण में सुधार करने के लिए विस्तृत सिफारिशें की हैं। ये सभी राज्य सरकारों और केन्द्र शासित क्षेत्रों को उनके द्वारा विचार तथा उपयुक्त कार्यवाही करने के लिए भेजी जा रही है और इस मंत्रालय में भी इन पर आवश्यक कार्यवाही करने के लिए इनकी जांच की जाएगी।

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE/ कृषि मंत्रालय में उप मंत्री (SHRI JAGANNATH PAHADIA) :

(a) Yes, Sir; in this report, lack of efficient management and high overhead costs are mentioned as the main reasons for the losses incurred by the cooperative stores, and other reasons have also been mentioned.

(b) Government is aware of these and other deficiencies in the working of consumer cooperatives. This Conference has made detailed recommendations for improvement in the working of consumer cooperatives. These are being sent to all State Governments and Union Territories for consideration and suitable action, and they will also be examined in this Ministry for necessary action.]
