In regard to mini buses, the State Transport Authority, Delhi, sanctioned 100 permits for such vehicles for operation in the Union Territory Delhi. Out of this, 70 permits have already been granted to private operators who are running mini buses in the city at present. They charge a paise and minimum fare of 35 maximum of Re. 1 as approved by the State Transport Authority. The D.T.U. maximum of Re 1 as approved by the last three years in the walled city on the routes which were earlier served by the Tramways. The fare charged by the Unertaking is not excessive. It is 20 paise minimum and 40 paise maximum.)
