- (b) the projects where actual work is yet to start; and
- (c) the steps taken by Government for equal distribution of foreign assistance received for the said purpose?

THE MINISTER OF STATE OF THE MINISTRY OF URBAN EMPLOYMENTAND POVERTY ALLEVIATION (KUMARI SELJA): (a) and (b) Presently two environmental improvement projects are being implemented with the foreign assistance in urban slum areas.

No project is being run at present with the help of foreign assistance for environmental improvment in urban slums in Himachal Pradesh.

(c) As and when, the Government of India, receives any proposal from the foreign donor agency offering assistance, it is circulated among the States/UTs seeking project proposals to avail the assistance. This Ministry examines various project proposals received from the States/UTs and gives its recommendations to the Department of Economic Affairs for taking up the matter with the concerned donor agency. However, finally it depends upon the concerned donor agency to select/approve the project proposals according to their policies and priorities.

This scheme is applicable to all the States in the country.
