EXPORT OF SALT

(b) if so, the reasons therefor; and

(c) what steps have been taken by Government to step up the export of salt?

(SHRI A. C. GEORGE): (a) Judging from the export trends during the past two years, it is possible that there may be a marginal decline in the export of salt during the current year.

(b) and (c). A statement is laid on the Table of the House.

STATEMENT

The declining trend in salt exports is mainly on account of the fact that one of our most important customers, namely Japan, has not been purchasing this commodity from India since July, 1970. The fall in the Japanese off-take from India is mainly due to

the increase in ocean freight rates and to the faster loading rates offered by other salt exporting countries such as Mexico and Australia.

Government are taking remedial measures to arrest the decline in salt exports. To compensate for the fall in the off-take by Japan, the STC which is the canalising agency for the export of salt has diversified the export of salt to other countries such as Tanzania, Republic of Korea, Thailand, Singapore and Nepal. The prices paid by these countries for our salt are higher than the prices offered by Japan. Efforts are also continuously being made by the STC to regain our share in the Japanese market and to improve the loading rate of salt at selected ports in India.

(b) No, Sir. Pensionary benefits have been liberalised from time to time since independence. Relief has

also been sanctioned to small pensioners. The rates of such relief have also been revised in the recent years.

(c) and (d) There is no proposal to include the case of pensioners in the terms of reference of the Pay Commission, but Government propose to consider, in due course, the question of grant of relief to pensioners in the light of general recommendations of the Pay Commission in the matter of pensionary benefits for serving Government servants.
