According to the information received from the State Government, a procession was taken out at Salem as a part of the Conference on "Eraof Superstitious dication Beliefs" sponsored by the Dravida Kazhagam, in which pictures of indu gods and godesses were displayed in a manner highlighting what the sponsors of the Conferene considered "the irrational aspect" in the Hindu religion. A case under section 153A and 295A IPC has been registered by the police in respect of the incident and is under investigation.

INDIA'S FOREIGN EXCHANGE EARNINGS FROM JUTE GOODS

(SHR A. C. GEORGE): (a) The value of export of jute goods during 1968-69; 1969-70 and 1970-71 was of order of Rs. 217.25 crores, Rs. 206.09 crores and Rs. 183.64 crores, respectively.

- (b) Exports of jute goods from India have declined.
- (c) Steps have been taken to prove the production and yield of jute and mesta. A good crop is expected in 1971-72. Diversification modernisation is being encouraged through soft loans from the IF.C., and this is expected to increase exports of carpet backing cloth. Export prospects for the current financial year are good.
