about 13,000 were new units. An amount of Rs. 13.46 crores was invested in these units. The value of production during 1969-70 is estimated to be over Rs. 10.00 crores. Employment opportunities were provided for more than 1,15,000 persons. Training facilities in improved techniques of production were provided to 35,000 persons and Common Facility Services were given to more than 80,000 small industrial units by the end of 1970. Financial assistance amounting to Rs. 6.75 crores was provided to the units located in the project areas while credit facilities provided by the State Bank of India exceeded Rs. 2.30 crores.

(c) Yes, Sir.

The area of the existing projects is being extended to cover the entire districts; 5 more new projects are being taken up-one in Haryana and 4 in the Rural Electric Cooperative project areas of Karimnagar District in Andhra Pradesh, Junagadh District in Gujarat, Belgaum District in Mysore and Lucknow District in Uttar Pradesh. It is also proposed that during the successive Five Year Plan period 50 new projects during each Plan period would be undertaken beginning from the 5th Plan period. For this purpose 50 new districts are to be selected and the preliminary work of survey of industries, preparation of schemes etc. is to be taken up in the next two years in order that these may form 50 new projects to be activated from the beginning of the 5th Plan. It is hoped to cover the entire country under the Rural Industries Projects Programme within a period of 25 years beginning from the 5th Plan period.

- (b) Letters of Intent for an annual capacity of 3 lakh numbers each of automobile tyres and tubes, have been issued in December, 1970, to the State Industrial Development Corporations of the first five States mentioned above. The applications from the State Industrial Development Corporations of U.P. and Rajasthan are under consideration.
