Deficit Budgets of States

121. SHRI A. D. MANI : Will the Minister of FINANCE/ वित्त मंत्री be pleased to state :

(a) whether it is a fact that many State Governments have presented deficit budgets without resorting to adequate fresh taxation ;

(b) the manner in which the States are going to cover up their deficits ;

(c) whether the Reserve Bank has been authorised to grant overdrafts to the State Governments to cover up the deficits ; and

(d) whether the State Governments have made any proposals to the Central Government regarding financial assistance for meeting the deficits ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE/ वित्त मन्त्रालय में राज्य मन्त्री (SHRI K. R. GANESH) : (a) to (d). Most States have presented Vote on Account budgets this year and the deficits shown therein do not indicate a complete picture which would be available only after the regular Budgets have been presented.
