

**Holiday on 30th June under Negotiable Instruments Act, 1881**

136. SHRI G. GOPINATHAN NAIR : Will the Minister of COMPANY AFFAIRS/ कम्पनी कार्य मंत्री

be pleased to state whether 30th June is a public holiday under Section 25 of the Negotiable Instruments Act so far as annual general meetings of Companies are concerned ?

THE MINISTER OF COMPANY AFFAIRS/ कम्पनी कार्य मंत्री

(SHRI K. V. RAGHUNATHA REDDY) : 30th June will be a public holiday if it is so notified under the Explanation to section 25 of the Negotiable Instruments Act, 1881. The powers under the said section of the Act to declare any day as a public holiday, have delegated to the State Governments by the Ministry of Home Affairs. The position in regard to 30th June being a public holiday so far as holding of Annual General Meetings under the Companies Act is concerned, will, therefore, vary from State to State.

**Konkan Shipping Line**

137. SHRI BABUBHAI M. CHINAI : Will the Minister of PARLIAMENTARY AFFAIRS AND SHIPPING AND TRANSPORT/

संसदीय कार्य तथा नौवहन और परिवहन मंत्री (SHRI RAJ BAHADUR) : (a) and (b). The Government of Maharashtra have forwarded to this Ministry the minutes of the emergency meeting of the Master Plan Committee, Maharashtra, recommending that the Konkan line passenger service should be taken over

either by the Central Government or the State Government as from September 1971, in view of the reported intention of M/s, Chowgule Steamships Ltd., not to reopen the Bombay/Dabhol line after the monsoon in September, 1971.

This is being examined.

**Asian Development Bank**

138. SHRI BABUBHAI M. CHINAI : Will the Minister of FINANCE/ वित्त मंत्री

be pleased to state what are Government's views on the suggestion for augmenting resources of the Asian Development Bank in Singapore ?

THE MINISTER OF FINANCE/ वित्त मंत्री

(SHRI Y. B. CHAVAN) : There is quite clearly need to augment the resources of the Asian Development Bank but the question is what kind of resources it should have and how these should be obtained. The level of ordinary lending by the Bank has exceeded \$ 200 million last year and, in our view, this is probably the limit of absorption. On the other hand the level of soft lending has only reached \$ 34 million last year and there is considerable scope for enlarging such lending. For this purpose the Bank must have special resources to be contributed by the more affluent countries.

The question of augmenting the resources of the Bank is presently under examination by the Board of Directors and we have asked that the examination be comprehensive enough to cover the question of soft loans.

(SHRI K. S. RAMASWAMY) : (a) There is total prohibition in Gujarat and Tamil Nadu. Partial prohibition is in force in the States of Assam, Haryana, Maharashtra, Mysore, Rajasthan and Uttar Pradesh.

(b) Prohibition being a State subject. it is for the State Government to enforce prohibition. Recently however, the Tamil Nadu Government has written to the Central Government to place the subject of Prohibition in the concurrent list.

(c) No assessment as such has been carried out.

(DR. KARAN SINGH) : (a) and (b). There were, in all, 4 demonstration flights of Air-India's Boeing 747 Jumbo jet "Emperor Ashoka" in Delhi on the 28th and 29th April, 1971.

The total number of passengers on the four flights was 879, which included some Ministers, Government officials, Customs, Immigration and Airlines staff and Commercial Contacts of Air-India.

The cost on the 4 demonstration flights was Rs. 54,500.00 approximately.
