PRICE OF DRUGS

*76. SHRI A. D. MANI: Will the Minister of PETROLEUM AND CHEMICALS/ पेट्रोलियम और रसायन मंत्री be pleased to state:

- (a) what steps have been taken by Government to reduce the price of drugs which are administered to heart patients; and
- (b) which of the companies have agreed to reduce the prices of those medicines?

THE MINISTER OF PETROLEUM AND CHEMICALS/पेट्रोलियम और रसायन मंत्री (SHRI PRAKASHCHAND B. SETHI): (a) and (b) Government have promulgated the Drugs (Prices Control) Order, 1970 to control and rationalise the prices of drugs with a view to giving some relief to consumers. In implementing the price control measures Government exercised proper care to bring down the prices of essential drugs which include cardiac preparations and common house-hold remedies. As a result of the price control, cardiac preparations also, among others have generally recorded appreciable reduction in prices. Some of the leading firms who have reduced the prices of these preparations are:

- 4. Post Graduates Institute of Medical Education and Research, Chandigarh.
- (b) A statement is laid on the Table of the Sabha.
- (c) The report of the Committee has not yet been received.

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS/ विदेश मंत्रालय में उपमंत्री (SHRI SUREN-

DRA PAL SINGH): (a) and (b) The House has already been informed in reply to Unstarred Question No. 329 on the 7th April, 1971 that the text of this statement was made available to the Government of India by the Canadian Government. It does not mention any partisanship by the Government of India, although it points out that Poland and India could have taken more action.

Government of India has taken all necessary action possible in the present circumstances prevailing in Laos. This has been suitably conveyed to the Canadian Government and to other parties concerned.

Another six Societies were defunct. Excluding these, there are 18 Societies which have not yet been offered land. A list of these Societies is placed on the Table of the Sabha. Their cases are at various stages of examination and it will take some time to finalise them.

(c) The dates of registration are being ascertained and will be laid on the Table of the Sabha when these are known.
