Maharashtra Government has submitted its report on mass transportation study of Bombay. The Traffic cell of the Tamil Nadu Government is expected to submit its report on 'Comprehensive Traffic and Transportation Study' for the Madras Metropolitan area by August, 1971'. However, it has submitted a report on 'Travel Corridors for 1991.'

(c) The reports already submitted are being considered by the Metropolitan Transport Team.

TELEPHONE BILLS OF COUNCIL OF MINISTERS

*110. SHRI S. A. KHAJA MOHIDEEN: Will the Minister of COMMUNICATIONS/ संचार मंत्री be pleased to state the amount paid for local and Trunk calls by each of the Councils of Ministers from 1st December, 19/0 to 31st March, 1971 in respect of Telephones provided at their residences?

THE MINISTER OF COMMUNICA-TIONS/संचार मंत्री (SHRI H. N. BAHUGU-NA): 1. In Delhi, bills for local calls are prepared quarterly, a quarter for the purpose being a conventional period of three months beginning from and ending at certain pre-determined dates, which varies for various groups of telephones. It will not therefore, be possible to identify the bills covering the calls made exactly during the period in question. A rough computation of such calls, however, has been attempted with reference to the records available in the telephone exchange. Local calls are valued at 15 paise per call up to 750 calls after allowing a rebate of 150 free calls and at 20 Paise per call thereafter per quarter. Valuation of the calls in the present case has been made hypothetically on a proportionate basis.

- 2. Bills for trunk calls are also issued monthly for conventional months which vary for various groups of telephones. Here, however, the value of all the trunk calls made during the period in question has been computed by referring to records relating to individual trunk calls.
- 3. Since the information is voluminous a statement embodying the same is laid on the Table of the Rajya Sabha. [See Appendix LXXVI, Annexure No. 6.]
