SALEM AND VIZAG STEEL PLANTS

- *141. SHRI LOKANATH MISRA: Will the Minister of STEEL AND MINES/इस्पात और खान मंत्री be pleased to state:
- (a) the Progress made by Government with regard to the erection of Salem and Vizag Steel Plants with details thereof; and
- (b) the total financial implications of these two projects and the date by which the two projects are likely to be completed?

THE MINISTER OF STEEL AND MINES/इस्पात और खान मंत्री SHRI S. MOHAN KUMARAMANGA-LAM): (a) and (b). A statement is laid on the Table of the House.

STATEMENT

(a) Following Government decision to set up theree new steel plants in the Southern States (in Mysore, Tamil Nadu and Andhra Pradesh) a number of Committees for selection of sites and supply of raw materials to the new steel plants were appointed. On the recommendations of the Site Selection Committee, sites for Salem and Visakhapatnam Steel Plants have been selected. The Salem Plant will be located in the Northern flank of the Kanjamalai hill, 14 k.m. west of Salem town and the Visakhapatnam plant at Balackeruvu, about 25 k.m south of Visakhapatnam along the coast.

On the joint recommendations of the Consultants and the Hindustan Steel Works Construction Limited

(a) public sector undertaking), project areas for both the plant sites have been demarcated. Land acquisition proceedings have commenced.

The Committees on coal and on raw materials other than iron ore and coal, have also submitted their reports. The Iron Ore Committee is likely to submit its report shortly.

Messrs M. N. Dastur & Co. Private Limited, have been appointed Consultants for the preparation of the Techno-economic Feasibility reports for both the Salem and Visakhapatnam Projects. It is expected that the Feasibility Report for the Salem Projects will be ready by the end of August, 1971, while that for the Visakhapatnam plant by November, 1971.

The Survey of India are undertaking detailed toprographical survey work for both the plant sites. The printed survey maps are expected to be ready by the end of June, 1971.

Hindustan Steet Works Construction Ltd. have been entrusted with the soil investigation work for both the Salem and Visakhapatnam plant sites. In the case of Salem Project, Hindustan Steelworks Construction Ltd. will also undertake the exploratory work in respect of Kanjamalai iron ore deposits, and they have set up a site office at Salem.

The proposals of the State Governments for supply of water to the Salem and Visakhapatnam plants are under examination. The Railways have commenced their survey work for the provision of marshalling and exchange yards and railway sidings, facilities etc. for both the plants.

(b) It is too early to indicate the financial implication of these two Plants and the tentative date by which these are likely to be completed. These aspects will be brought out in the Techno-economic Feasibility Reports by the Consultants.
