(b) and (c) Yes, Sir, Government have recently issued Letters of Intent to new entrepreneurs for additional capacity to the tune of 24 lakh numbers per annum. This with the existing approved/installed capacity of 55 lakh numbers per annum is expected to take care of the increasing future demand for tyres.
