THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K. C.PAN1): (a) to (c) On December 16, 1970, extremist prisoners became unruly and violent and , traed with brickbats, iron rods etc looiod from the jail blacksmithy,

Stacked the other prisoners who did not Join them in creating disturbance in the jail premises. They also tried to escape from the jail by attacking the jail warders who had to open fire in self defence to prevent their escape. 9 persons were killed, 2 due to bullet injuries and 7 due to injuries inflicted by sharp cutting and blunt weapons. 25 persons, including 15 members of the jail received injuries.

He was seriously injured and admitted to the SSK.M Hospital, the case is under investigation. Uptodate information about the number of persons arrested and the result of investigation is being collected from the State Government and will be laid on the table of the House.
