imports are allowed are given in the Import Trade Control Policy (Red Book). As mentioned therein, import is allowed normally for hospital equipment and appliances, fountain pen nibs, razor blade, watch industry and other industrial uses except for manufacture of utensil cutlery, kitchen ware, table tops and furniture. Registered Exporters' Import Policy permits, however, import of stainless steel even for manufacture of utensils, cutlery etc. against export of stainless steel utensils, cutlery, etc.

- I. The following preventive steps are being taken to minimise the incidence of thefts in running trains:
- (1) Proper rivetting, E. P. locking (E. P. Ellis Patent) and pad locking of wagons carrying valuables is insisted upon to prevent criminal interference.
- (2) Escorting of goods trains carrying valuable consignments/foodgrains in open wagons is done by R.P.F. personnel, specially in vulnerable sections. Patrolling by armed R.P.F. personnel as well as dog squads in affected places is also undertaken.
